SECTION 3 HAZARDS IDENTIFICATION

Extinguishing Media -

Use water fog, foam, dry chemical or CO2. Use water spray to cool fire-exposed containers and to protect personnel.

Special Fire Fighting Procedures -

Keep containers cool and vapors down with water spray. Prevent spill from entering drains, sewers, streams or other bodies of water. If run-off occurs, notify proper authorities.
